

## **Privacy Policy**

TransCounty Title Co. respects your right to privacy. This Privacy Policy summarizes what nonpublic personal information we may collect through this website and how we might use and disclose this information. This Privacy Policy does not govern our use of any information you provide to us when you call us, write to us (including via e-mail), or communicate with us in any manner other than through this website. Because the Internet is global, information about you that we collect or that you submit may be transferred to, processed in, and held in countries (including the United States) other than the one in which you reside. By using this website, you explicitly consent to such collection and use of your nonpublic personal information and agree to the terms of this Privacy Policy. This Privacy Policy is effective as of January 1, 2015.

### **Information Collection**

You can visit this website without disclosing any nonpublic personal information (such as name, address, telephone number, or e-mail address). If, however, you wish to access certain products or services that we make available through this website, you may be required to provide certain nonpublic personal information. TransCounty Title Co. will only collect nonpublic personal information that you voluntarily provide. We may use cookies (which are small text files placed on your hard drive by a web server), web beacons (sometimes called single-pixel gifs) and other technologies to track and collect general information about your visits to this website (such as your IP address, the type of browser you use, the files you request, which parts of the website you are visiting, how long you spend there, your domain name and the country from which your request originates). While IP addresses (the Internet address of a computer) are logged to track a user's session, the user remains anonymous as we do not link your IP address to any nonpublic personal information you may provide. If you choose to accept cookies, you can also usually use your web browser to delete cookies you have accepted. We do not collect nonpublic personal information from your online activities over time and across other websites or online services, and we do not allow third parties to use these technologies on this website. Because we do not use these technologies, we do not respond to web browser "do not track" signals or other similar mechanisms.

### **Use of Information**
